Higher Learning Commission Grants Full Accreditation to Saint Paul School of Theology

Congratulations to all who participated in the two-year effort to address the concerns of our primary accrediting agency, the Higher Learning Commission. In mid-March, the HLC informed us that the institution has been removed from probationary status. You can read more about the decision and standards of the HLC at spst.edu/accreditation/. The institution will continue to work with the HLC on matters related to learning assessment and planning necessary for reversing declining enrollment. Two important outcomes resulted from this process. First, the institution significantly improved its operational and governance practices and, second, the board and leadership team can now focus more on the future of the institution.

Board Development – Wise Stewards Initiative: Governance as an Agent for Change

As an important step in board development, a group from Saint Paul recently attended a day and a half workshop in Vancouver, Washington courtesy of a grant from M.J. Murdock Charitable Trust. Participants included Trustees Parmely, Sample and Lindahl and President Blair. Preliminary work included preparation of a profile of the Saint Paul board (available in the trustees Moodle folder), the Wise Stewards Guide (available on the In Trust Center for Theological Schools website), and assigned reading of the book *Canoeing the Mountains: Christian Leadership in Unchartered Territory* by Dr. Tod Bolsinger. The thirteen-hour first day of the seminar began with a presentation by author Bolsinger, who serves as Vice President and Chief of Leadership Formation at Fuller Theological Seminary. He chartered the course for our learning as each seminary's president and trustees shared a table with their counterparts from another free-standing seminary. We discovered that we are much more alike than different in meeting the missions of our institutions. A recording of the seminar sessions will be available soon for more in-depth discovery.

There were numerous opportunities to interface with the other nine seminaries and hear their stories and challenges. We heard many of the same uncertainties about enrollment and funding that we face. We also learned about institutional growth and how some seminaries are expanding opportunities to meet their mission. The boundaries between appropriate board leadership and governance versus management was a common thread for discussion throughout the presentations and informal gatherings. In summary, a central theme for the fast-paced seminar was introduced by Dr. Amy Kardash when she met with the Saint Paul School of Theology Board during its Fall, 2018 meeting. Amy underscored the four pillars of good board governance:

- mutual accountability,
- communication about things that matter,
- transparency,
- and trust.

Looking back at our two board self-surveys, including the Fall, 2018 survey (see November 2018 *Board Notes*), we are strengthened by our participation in this opportunity facilitated by In Trust. Our next steps will include the exploration of shared governance as a means of moving forward in partnership for the future of Saint Paul, its mission, and its students.
